



CHURCH OF THE RESURRECTION

Restrictive Access Agreement for Registered Sex Offenders

Church of the Resurrection cannot guarantee that we can accommodate an ex-offender's request to attend our congregation. We maintain the right to revoke his/her ability to worship with us at any time. We prioritize the safety of our children and youth, and must ensure that our pastoral leaders have the necessary resources to maintain careful oversight of his/her engagement in our church. The following document serves as a sample agreement.

Church of the Resurrection ("We" "Resurrection"), of Wheaton, IL, is a house of worship. Our heart is to invite everyone into a transforming relationship with Jesus and his Church, so that men, women, children and youth can meet the Lord and be changed by his love. We want our church to be a safe place for everyone. We understand that you have a criminal conviction and that you are currently registered as a sex offender in the State of Illinois. Accordingly, we have serious concerns about potential contact between you and Church of the Resurrection's children and youth. In order to safeguard them, and to provide you with an opportunity to worship in our midst, we require you to agree to and strictly comply with the Conditions of this Restrictive Access Agreement ("Agreement"). Such compliance is an essential condition for your continued presence at Church of the Resurrection and your participation in Resurrection's worship, activities, ministries, and functions.

Definition of Terms

In the following statement of conditions, these terms shall have the assigned meanings:

- Service(s): includes any gathered event of Resurrection, whether held at the facility owned by the Resurrection or at an offsite location.
- RezGroup: includes any meeting of a Resurrection group under the authority and leadership of Resurrection, whether in a home, at a Resurrection location, or other location.
- Activities: includes services, Rez groups, service events, retreats, conferences, or any other function sponsored by Resurrection, regardless of the event location.
- Participation: includes any involvement in, and physical presence at, any Resurrection Services, Resurrection-leased or Resurrection-owned Properties, RezGroups, and Resurrection Activities as defined herein.
- Members: individuals who have met the criteria for membership, have been admitted to the membership of Resurrection, and continue in good standing.
- Supervising Pastor: A pastor of Church of the Resurrection designated by the pastoral staff to oversee the fulfillment of this contract with a given sex offender in fellowship with

Resurrection.

- Escort: an approved delegate overseen by a staff member who is present with a sex offender attending a Resurrection service or activity, and who monitors the sex offender's restroom use while onsite.
- Child or children: any person under the age of 18 years old.

Conditions

1. You will authorize Resurrection and its representatives to contact your court ordered officer (CCO) at any time during the period of your Participation in Resurrection. You understand that we may ask your CCO for information related to your offense, and any related restrictions on your conduct.
2. You will be assigned a Resurrection supervising pastor who will evaluate and monitor your Resurrection Participation.
3. You will meet with the court ordered officer (CCO) as prescribed by the Court.
4. You will provide the treatment therapist's name and phone number and the CCO's name and phone number to your Supervising Pastor.
5. You agree to have your picture, name, offense level, and a copy of this signed Agreement emailed to designated Resurrection pastoral staff, vestry, and Youth and Children's staff leaders once a year.
6. You agree that the pastoral staff of Resurrection may, in their sole discretion, deem it to be in the best interest of Resurrection to disclose information related to your criminal conviction, your status as a registered sex-offender, as well as information related to this Agreement, to specific Members of Resurrection and you hereby consent to the disclosure of such information to the Members of Resurrection.
7. You will not attend Resurrection services or activities (nor be present on the property of the Resurrection or off-property gathering location) without your supervising pastor or an escort, as approved and assigned by Resurrection senior staff. The senior staff will approve your supervising pastor and any additional escorts in the senior staff's sole and absolute discretion. If your supervising pastor or an approved escort are not available, you will not attend any Resurrection services or activities (nor will you be present on the property of Resurrection or off-property gathering location) at any time.
8. Immediately upon your arrival at a Resurrection parking lot, you will meet your supervising pastor or approved escort at a pre-agreed location. You will wait there until your supervising pastor or escort is able to be present with you.
9. You will not serve in any role in a Resurrection ministry without prior approval from your supervising pastor.
10. You acknowledge and agree that ALL CHILDREN'S AREAS ARE OFF LIMITS AT ALL TIMES.
11. You will not visit the home of a Resurrection family where children are present or invite a family with children into your home, without the parent knowing that you are a registered sex

offender. You will also notify your supervising pastor prior to the visit. You understand that your supervising pastor may contact such family to discuss your visit with such family prior to the visit.

12. You will not have any physical contact with a child at Resurrection, including, without limitation, sitting next to a child other than your own, holding a child on your lap, or being hugged or kissed by a child at Resurrection. If a child other than my own approaches you to talk, you will acknowledge him or her, but you will promptly leave the area unless the child's parent is present and included in the conversation. You will report any such contact to your supervising pastor or escort before leaving Resurrection premises.
13. You will not have any phone or electronic communication with a child from a Resurrection family.
14. You will only use the bathrooms after your supervising pastor or approved escort has entered and found no children in the room. Your supervising pastor or escort will monitor the door while you use the facility.

I _____ hereby release Resurrection, and all of its present and former pastors, officers, directors, staff and other employees, RezGroup leaders, and members, from all claims, demands, suits, or causes of action of whatever nature or source, whether in law or in equity, without limitation, claims for attorneys' fees and costs, based upon or arising out of or related in any way to this Agreement, and/or arising from any disclosure of information under this Agreement.

Consent, Authorization, and Release Form

I have requested access to the property and/or activities of Church of the Resurrection of Wheaton, IL, and, in Resurrection’s discretion, it has required me to sign and abide by the Church of the Resurrection Restrictive Access Agreement (“RAA”), which is attached hereto, and which is incorporated by reference into this Consent, Authorization, and Release (this “Consent”). I understand that Church of the Resurrection would not enter into the RAA with me if I did not agree to the terms in this Consent.

1. As the above-named individual, I authorize the disclosure and use of my medical records including those related to treatment by therapists, psychologists, or other mental health professionals, parole, probationary and court records (even if expunged/under seal), and any related records (the “Records and Information”).
2. I understand that individuals or organizations which Church of the Resurrection may ask to disclose the Records and Information may require me to execute further authorizations in order to release them, and I agree to promptly execute these further authorizations. If I do not, Church of the Resurrection has the right to immediately revoke the RAA.
3. I understand that the information in my Records and Information may also include information about behavioral or mental health services, and treatment for alcohol and drug abuse, and may disclose information relating to sexually transmitted disease, acquired immunodeficiency syndrome (AIDS), or human immunodeficiency virus (HIV).
5. This Records and Information may be disclosed to and used by Church of the Resurrection and its employees and staff for purposes of evaluating, monitoring, and reducing risk of incident.
6. I understand I have the right to revoke this Consent at any time. I understand if I revoke my Consent, I must do so in writing and present my written revocation to a Church of the Resurrection pastor. I understand the revocation will not apply to information that has already been released in response to this Consent. Unless otherwise revoked, this Consent will expire in one (1) year from the

date below. I understand that revoking my consent will automatically result in a revocation of the Restrictive Access Agreement (RAA), as well as any privileges of Participation in Church of the Resurrection, as defined in the RAA.

7. I understand that authorizing the disclosure of the Records and Information is voluntary. I can refuse to sign this Consent. I understand any disclosure of Records and Information carries with it the potential for unauthorized re-disclosure and the information may not be protected by federal confidentiality rules.

8. I hereby release Church of the Resurrection and its agents, employees, volunteers and chaperones from any and all claims, damages or injury arising out of or related to this Consent, including but not limited to defamation actions, employment actions, intentional infliction of emotional distress, breach of duty, invasion of privacy, or arising out of or related to the disclosure of any Records or Information or rendering of any opinion given under this authorization, whether under Illinois or federal statute, regulation, or common law, to the fullest extent allowed by law.
